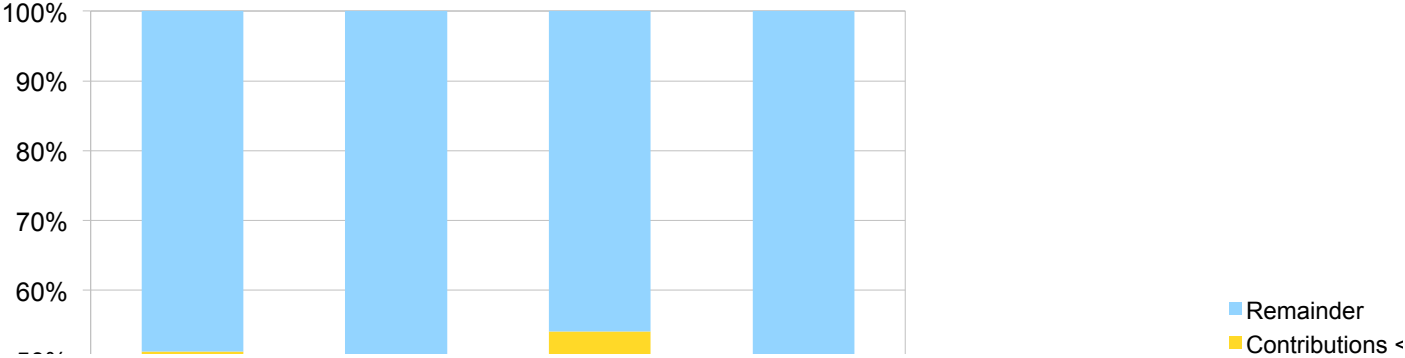

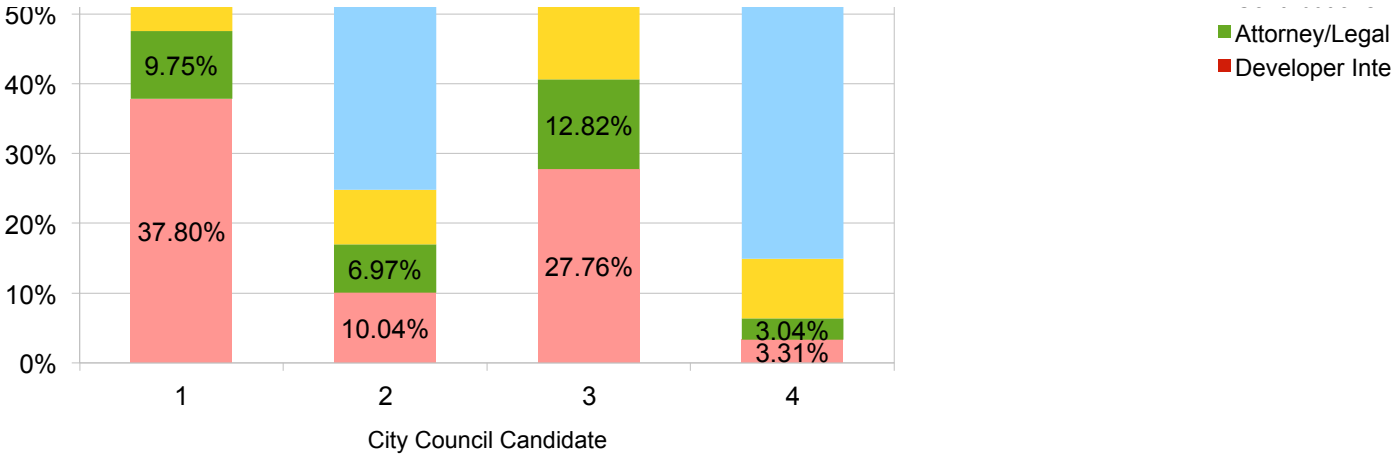

LB 2016 City Council Donor Breakdown

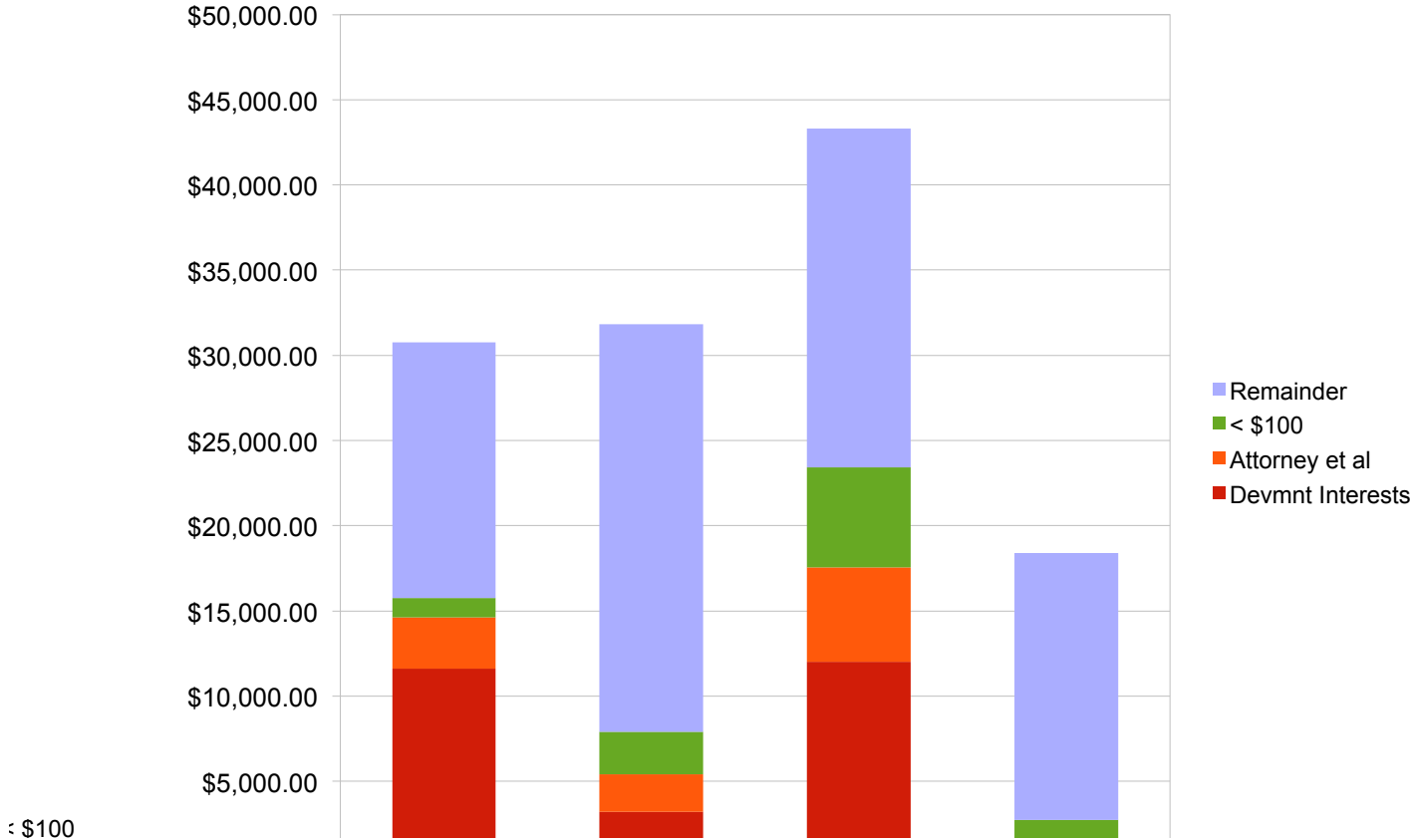
