Dear Ms. Korchmaros,

Please accept this letter on behalf of Mayor Steve Dicterow, City of Laguna Beach. I am responding to a letter received by Mr. Dicterow yesterday, October 24, 2016, at 5:30 p.m., advising of a complaint filed with the Commission by Michael Morris and James Mouradick. The complaint concerns real property owned by Mayor Dicterow and his wife in Laguna Woods, California.

Upon reviewing the material submitted by Mr. Morris and Mr. Mouradick, including a map provided showing that the Laguna Woods property is located 1.455 miles "as the crow flies" from the outermost property boundary in Laguna Beach (61 La Costa Court), Mayor Dicterow has prepared and has submitted today for filing an original, Amended Schedule B to Form 700, detailing the real estate interest and rental income derived therefrom. Mr. Morris and Mr. Mouradick also included with their complaint a copy of the Dicterow Chapter 11 Bankruptcy Schedules from September, 2014, and a public record detailing all of Mayor Dicterow's family assets and obligations, including the Laguna Woods property. A copy of Mayor Dicterow's amendment documents is attached hereto.

When completing the Schedule 700 Form, Mayor Dicterow did not believe the Laguna Woods property to be within the area of his jurisdiction, Laguna Beach, as that information was requested by Schedule B on Form 700 and its accompanying "Instructions."

Mayor Dicterow regrets any issues or problems created by this mistake and hopes that the submittal of the Amended Form 700 corrects the matter to the satisfaction of the Commission.
