Notes/Narrative

On June 6, 2020, at approximately 0935 hours, I responded to the Hotel Laguna located at 425 S. Coast Hwy, in reference to a trespassing report.

Upon my arrival, I contacted the hotel manager Gregory Paul, who told me the following:

On June 6, 2020, at approximately 0915 hours, Paul was overseeing construction occurring in the closed hotel, when he observed a male who he recognized as Ruben Flores, inside the hotel, taking photos near the first-floor hallway. Paul told Flores to leave and he complied. Paul believes Flores entered the hotel via a ramp that leads from the parking lot to the courtyard.

A "No trespassing" sign is posted on a large piece of plywood that blocks the walkway to the hotel. Additional no trespassing signs are posted around the hotel property.

I later spoke with Mohammad Honarkar, the owner of the hotel. Honarkar told me the following:

Flores is a tenant of his at a separate property. Honarkar has been having ongoing issues with Flores and attempted to evict him in February 2020. Due to COVID-19, the eviction process was delayed. Since then, Flores has not been paying rent. On May 29, 2020, Flores was served with eviction paperwork. Honarkar believes Flores trespassing at the hotel and taking photos was retaliation. Honarkar was concerned about the photos taken and did not want them posted anywhere.

Honarkar was desirous of prosecution against Flores. Paul signed a private person's arrest form on behalf of the hotel.

I later attempted to contact Flores via telephone and in person at his business, Laguna Nursery located at 397 N. Coast Hwy, but was unsuccesful.

A copy of the eviction notice Flores was served with, valid trespass letter, and private person's arrest form is attached with this report.

Honarkar was provided with my business card and case number.

I request this case be forwarded to the District Attorney's Office for review and prosecution.
