Notes/Narrative

On 01/11/20, at approximately 1338 hours, I was on uniformed patrol in marked police unit 852. I was dispatched to 361 Holly Street, for the report of a possible vandalism.

I arrived at the location and met with the reporting party (RP) Steve Dicterow, City of Laguna Beach Council Member, who told me the following:

Last night on 01/10/20, at about 2130 hours while he was away from his residence, unknown subjects placed what appeared to be animal feces on his front doorstep, along with a medium sized Christmas tree that was blocking the walkway to his door. His wife Catrina was home at the time and heard what appeared to multiple young males (estimated 12-13 years old) giggling outside while knocking on the door. Dicterow arrived at his home only a few minutes after Catrina heard them outside, but did not see anyone in the area. He proceeded to the walkway of his front door when he noticed the tree and feces. There are two small signs in the front yard of his house, one that say`s "Please don`t block the walkway," and another that say`s "Choose to be kind." Both of these signs were removed from the standing position they were in on the grass and laid down in the yard.

At the time of my arrival, the feces were removed from the doorstep and the tree was moved to the alley at the rear of Dicterow`s property. There was no damage to his home and he could not think of any person who would have committed this act.

I canvased the entire neighborhood, spoke to multiple neighbors and was unable to locate any witnesses or video surveillance.

This report is for documentation purposes, should another event take place at a future time. Dicterow was provided a personal business card should more information become available, and a case number to reference the incident report.

The audio and video component of the contact was captured on my Watch Guard body worn camera.

Notes/Narrative

On April 14, 2020, at approximately 1253 hours, I was dispatched to Steve Dicterow's residence at 361 Holly Street. The reason I was dispatched was due to an Extortion Investigation. The following is a summary of Dicterow's statements:

On April 14th, at approximately 1238 hours, Dicterow received a phone call from telephone number #527621100749. Dicterow answered the phone and a female with a Hispanic accent was on the other line. The female was crying hysterical and was telling Dicterow, "He's Dead". After a few moments, a male with a Hispanic accent took over the conversation with Dicterow. The male suspect told Dicterow that he had his daughter and demanded money. No specific amount was requested by the suspect nor did the suspect know Dicterow's daughter's (adult) name.

Dicterow's daughter was safe the whole time at her residence in Costa Mesa and this was confirmed by the Costa Mesa Police Department.

The male subject also wrote text messages to Dicterow stating he was going to come get him and kill him. He also called Dicterow a "Bitch".

Dicterow received approximately 14 phone calls from the above noted phone number which appeared to come back to the Country of Mexico. Dicterow was eventually going to block the phone number, so it could no longer contact him.

Reserve Officer Lance Larson did a work up on the phone number and confirmed it did come back to Mexico as the country of origin. No suspect(s) information was obtained.

I did document this incident with the Federal Bureau of Investigation, Internet Crime Complaint Center (IC3). Due to Dicterow being a City Council Member for the City of Laguna Beach. My IC3 report is attached for review.

I later contacted Dicterow and told him a work up was done on the phone number and it came by to Mexico. He was thankful for the follow-up phone call.

Due to the Suspect(s) being in Mexico, no follow-up is required at this time.

Sergeant J. Schmidt and Lieutenant T. Kleiser was also on scene.
